


The applicant is requesting subdivision approval to further subdivide lot 16 an existing 0.97-acre lot on the south side of Stateline Road (Main Street) east of Hwy. 51 in the Southaven Subdivision Section "B". There are two existing multi-tenant buildings located on the lot that seem to be separated via a twenty (20) foot drive between them. There is shared parking throughout the site. The applicant is requesting to take the overall lot and break it down into two lots consisting of lot 16a with 0.48 acres and lot 16b with 0.49 acres. The plat shows a common ingress/egress that will carry from lot to lot to provide cross access.

Staff Recommendations:

Per city ordinance, there is no side yard setbacks associated with C-3 zoning which would appease the concerns that staff had along the east and west ends of the lots. There is also no lot size minimum which is the case for other zoning districts. The shared ingress/egress and common drive remains to allow for shared parking. There are no additions or revisions to the structures therefore any new compliance requirements would not come into effect for this application. This revision would formally allow one building to stand autonomously and/or be sold without the conditions for the other building which is a standard procedure. Staff has no comments and recommends approval as submitted.






The applicant is requesting subdivision approval for a one lot minor subdivision on the north side of Desoto Road, east of Hwy. 301. The family owned property encompasses more than eight (8) acres total but the applicant is looking to carve out one (1) acre with an existing home on the site to deed to a family member. Per city ordinance AG property must have a minimum of one acre per lot and a minor subdivision can have no more than three (3) lots and zoned AG which is the case with this application. The boundary survey shows the forty (40) feet of dedicated right of way for Desoto Road. The existing house is accessed by a private drive on the east side of the lot. There are no identified easements on the lot.


Staff Recommendations:

The only concerns that staff would have are the private drive and lot easements. Although the property is proposed for family use only there may be a time in the future where that is not the case and without an ingress/egress easement it limits the accessibility for the overall site. It would be the staff's recommendation that the drive be placed in an easement form for reference. It would also be beneficial to place the standard lot easements on the lot so in the future when/if it is further subdivided that utilities have access as needed to the boundaries of both this lot and possible future ones.


Staff Comments:

The applicant is requesting subdivision approval for Wilco Commercial Subdivision on the north side of Nail Road between Elmore Road and Airways Blvd. The total acreage encompasses 11.76 acres and the applicant is requesting to subdivide it into 11 lots ranging in size from 0.78 acres to 1.95 acres. The site will have direct access off of Nail Road with a single cove design. The right of way is shown at fifty (50) feet for two-way access and a proper cove radius to allow for truck and emergency vehicle turn around. There is an existing shared ingress/egress on the back side of lots 4 and 5 which shows fifteen (15) feet of the width on these lots. There is an additional fifteen (15) feet of width on the property owners to the north. A creek line runs along the eastern boundary of this lot which is identified with a twenty-five (25) foot drainage easement. An additional twenty-five (25) foot drainage easement is being shown along the ingress/egress of lots 4 and 5. The Nail Road improvements were completed prior to this proposed development therefore there is no additional right of way or improvements needed by the applicant. All bulk regulations and setbacks have been shown on the preliminary plat.

Staff Recommendations:

This plat should be recorded after the original lot 1 of the Whitfield PUD is vacated. The original lot 1 of Whitfield Commercial was put in place for a previous development that never came to fruition and therefore the lot is no longer needed. Staff will work with Oakhurst Development, who is still shown to be the owner of the property, to have the lot vacated prior to this recording. The original PUD documents show the ingress/egress on the back of lots 4 and 5 to be fifty (50) feet which is numerically different than what is shown on the proposed plat presented. 
Staff Comments:

The applicant is requesting subdivision approval to subdivide 2.59 acres of property on the east side of Hwy. 51, south of Church into four (4) lots ranging in size from 10,281 sq. ft. to 35,556 sq. ft. There is also a proposed parcel "A" which is directly adjacent to Hwy. 51 which has an existing sewer pump station owned and operated by the City of Southaven utility department. This parcel encompasses 24,941 sq. ft. and has an existing access point off of Hwy. 51. There is a thirty (30) foot drainage easement from Sweetwater Drive down lots 2 and 3 and then crossing along the rear property line of lots 3 and 4 which is shown on the plat to be a public easement. A continuance of the fifteen (15) foot landscape buffer and perimeter wooden fence is shown along the back side of the private lots.


Staff Recommendations:

The proposed application meets the requirements set forth in the planned unit development regarding lot sizes. The application shows a perimeter wood fence along the residential lots which is agreeable since it matches the rest of the subdivision; however, the parcel where the pump station is located should have a vinyl coated black chain link fence with privacy slats incorporated to match the other city facilities. All other bulk regulations set forth in the ordinance have been met and staff recommends approval.





Per your request, on May 30, 2019, our firm made a visual inspection of the building located at 1179 Main St. Southaven MS. The purpose of the inspection was to evaluate the structural integrity of the building due to water and fire damage.

The following report is based on visual observation; no calculations were performed, and the evaluation is based on engineering judgment and experience.

GENERAL DESCRIPTION:

The building is a one story structural with a wood framed roof system supported on masonry exterior walls and wood stud interior walls. The building was originally constructed for Taco Bell.

OBSERVATION:

- The exterior of the building appeared to be in good condition; photos1-3.
- 2. The east section of the main structural was damaged at the roof; photo 4.
- 3. Several areas of the roof rafters and wood deck were damaged from the exposure of water and fire; photos 5-10.
- 4. Interior wall plate at mechanical duct had deflected; photo 11.
- 5. Roof beam not securely connected to load bearing wall; photo 12.
- 6. Roof rafters for west section of structural were supported on interior load bearing wall.

CONCLUSION:

- 1. The exterior walls and north section of the building appeared to be in good condition.
- 2. The building has several areas of deteriorating roof rafters and wood deck due to leaky roof as illustrated in the attached photos.
