Mayor Pro Tempore Cady called the meeting to order. Alderman Payne led in prayer, followed by the Pledge of Allegiance led by Alderman Brooks. Motion seconded by Alderman Brooks. Motion was put to a vote and passed unanimously.

MYERS TIRE SYPPLY DISTRIBUTION, INC. –Resolution Granting Exemption From Ad Valorem Taxes for a Ten Year Period

RESOLUTION OF THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF SOUTHAVEN, MISSISSIPPI, GRANTING EXEMPTION FROM AD VALOREM TAXES FOR A TEN YEAR PERIOD TO MYERS TIRE SUPPLY DISTRIBUTION, INC. AS AUTHORIZED BY SECTION 27-31-101 ET SEQ., OF THE MISSISSIPPI CODE (1972), AS AMENDED

WHEREAS, MYERS TIRE SUPPLY DISTRIBUTION, INC., filed an Application in triplicate for exemption from ad valorem taxation, except ad valorem taxes levied for school district purposes ("school district taxes"), parks and library, and the "mandated levies" described in Section 27-39-329 of the Mississippi Code Annotated (1972) with this Board; and

WHEREAS, MYERS TIRE SUPPLY DISTRIBUTION, INC., has produced written verification and documentation to this Board as to the authenticity and correctness of its Application in regard to the true value of the prayed for exemption and the completion date of said enterprise; and

WHEREAS, this Board finds as a fact that the property described in the aforesaid Application constitutes an industrial enterprise of public utility as enumerated in Section 27-31-101 of the Mississippi Code Annotated (1972), which was completed on the 2nd day of May, 2011, and that said Company is entitled to the exemption sought for a period of ten (10) years beginning on May 2, 2011, subject to approval and certification by the Mississippi Department of Revenue.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Board of Aldermen of the City of Southaven, Mississippi, as follows, to-wit:

1. That the Application for ad valorem tax exemption for MYERS TIRE SUPPLY DISTRIBUTION, INC., for a period of ten (10) years, beginning on May 2, 2011, on the tangible property (other than tagged motor vehicles and finished products) used in, or necessary to, the operation of MYERS TIRE SUPPLY DISTRIBUTION, INC. as described in the Application filed by said Company for tax exemption, be and the same is hereby approved, subject to approval and certification by the Mississippi Department of Revenue.

- 2. That MYERS TIRE SUPPLY DISTRIBUTION, INC. is hereby granted exemption from ad valorem taxation, except school district taxes, parks and library taxes, and the "mandated levies", on the eligible exempt tangible property as described in Exhibit "A" of the Application having a true value of \$560,670.00 for a period of ten (10) years beginning on May 2, 2011.
- 3. That the Clerk of this Board is hereby directed to spread a copy of this Resolution on the minutes of this Board; and that said Clerk shall forward the original and one (1) certified copy of the Application and a certified copy of the transcript of this Resolution approving said Application to the Mississippi Department of Revenue for its approval and certification; and said Clerk shall also forward one (1) certified copy to the Tax Assessor of DeSoto County, Mississippi, and obtain the Certificate of said Tax Assessor stating that the personal property as itemized in the Application has been placed on the appropriate tax roll as "Non-Taxable", except for school district, parks and library taxes and the "mandated levies" for the duration of the exemption period only.

 After a full discussion of this matter, ALDERMAN Payne moved that the foregoing Resolution be adopted. The motion was seconded by ALDERMAN Hale.

Alderman Jobes made the motion to table this matter until the January 20, 2012 meeting. He is asking that someone from Myers Tire Supply Distribution, Inc., be present at that meeting. Motion was seconded by Alderman Brooks.

Motion was put to vote and passed unanimously.

WHEREUPON, the foregoing Resolution was declared tabled until the January 17, 2012 regular meeting of the Mayor and Board of Alderman of the City of Southaven, Mississippi, on this, the 3rd day of January, 2012.

MYERS TIRE SUPPLY DISTRIBUTION, INC.—Resolution Granting Exemption From Ad Valorem Taxes For Operator Of A Free Port Warehouse.

RESOLUTION OF THE MAYOR AND BOARD OF ALDERMEN OF CITY OF SOUTHAVEN, MISSISSIPPI GRANTING EXEMPTION FROM AD VALOREM TAXES

The Board next took up for consideration the matter of granting to MYERS TIRE SUPPLY DISTRIBUTION, INC., hereinafter referred to as "APPLICANT", operator of a Free Port Warehouse within the City of Southaven, County of DeSoto, State of Mississippi, an exemption from all ad valorem taxes to the full extent permitted by statute on all personal property held in the APPLICANT'S finished good warehouse and in transit through the State of Mississippi and which either is moving in interstate commerce through or over the territory of the State of Mississippi or is consigned or transferred to the APPLICANT'S finished goods warehouse for storage in transit to a final destination outside the State of Mississippi, and the following Resolution, having first been reduced to writing was introduced:

RESOLUTION OF THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF SOUTHAVEN, MISSISSIPPI GRANTING EXEMPTION FROM AD VALOREM TAXES TO THE FULL EXTENT PERMITTED BY STATUTE

TO MYERS TIRE SUPPLY DISTRIBUTION, INC., OPERATOR OF A FREE PORT WAREHOUSE, AS AUTHORIZED BY SECTION 27-31-53 OF THE MISSISSIPPI CODE (1972), AS AMENDED

WHEREAS, the APPLICANT is a corporation organized under the laws of the State of Ohio with a finished goods warehouse located within the City of Southaven, County of DeSoto, and State of Mississippi, which is regularly engaged in the handling and storage of personal property in structures or places

adapted for such handling and storage and to which personal property is consigned or transferred for storage and handling in transit to a final destination outside the State of Mississippi; and

WHEREAS, the APPLICANT has negotiated in good faith with the Mayor and Board of Aldermen as to the ad valorem tax exemption authorized by Section 27-31-53 of the Mississippi Code (1972), as amended;

WHEREAS, the APPLICANT has applied for a license to operate the Free Port Warehouse to be issued by the DeSoto County Tax Assessor and has certified in the application for such license that APPLICANT ships personal property to a destination outside of the State of Mississippi each year and APPLICANT is qualified to apply for the free port warehouse ad valorem tax exemption;

WHEREAS, the APPLICANT currently provides employment in the City of Southaven, County of DeSoto County, State of Mississippi, for approximately 41 persons with an estimated annual payroll of \$431,000.00;

WHEREAS, the APPLICANT is qualified to make application for exemption from ad valorem taxes pursuant to Section 27-31-53 of the Mississippi Code (1972), as amended;

WHEREAS, this Mayor and Board of Aldermen of the City of Southaven, Mississippi, acknowledge the APPLICANT'S major contribution to the economic development of the City of Southaven and the County of DeSoto and State of Mississippi; and believe that it should exercise its discretionary authority to exempt from all ad valorem taxes to the full extent permitted by statute all personal property held in the APPLICANT'S finished goods warehouse and in transit through the State of Mississippi and which either is moving in interstate commerce through or over the territory of the State of Mississippi or is consigned

or transferred to the APPLICANT'S finished goods warehouse for storage in transit to a destination outside the State of Mississippi.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Board of Aldermen of the City of Southaven, Mississippi, as follows, to-wit:

- 1. That the APPLICANT, MYERS TIRE SUPPLY DISTRIBUTION, INC., operator of a free port warehouse is hereby granted exemptions to the full extent permitted by statute beginning on the 2nd day of May, 2011, from all ad valorem taxes on all personal property held in APPLICANT'S finished goods warehouse and in transit through the State of Mississippi and which either is moving in interstate commerce through or over the territory of the State of Mississippi or is consigned or transferred to APPLICANT'S finished goods warehouse for storage in transit to a final destination outside the State of Mississippi, as authorized by Section 27-31-53 of the Mississippi Code (1972), as amended.
- 2. That the Clerk of this Board be, and she is hereby directed to spread a copy of this Resolution on the minutes of this Board; and that said Clerk shall forward a certified copy of this Resolution to the DeSoto County Tax Assessor.

After a full discussion of this matter, ALDERMAN Jobes moved that the foregoing Resolution be tabled until the Mayor and Board of Alderman meeting of January 17, 2012. The motion was seconded by ALDERMAN Brooks.

Motion was put to vote and passed unanimously.

WHEREUPON, the foregoing Resolution was declared tabled until the regular meeting of the Mayor and Board of Alderman of the City of Southaven, Mississippi, on this, the 17th day of January, 2012.

SOLE SOURCE-IMPROVED CONSTRUCTION METHODS FOR HURCO VALVE MACHINE REPAIR-UTILITY DEPARTMENT:

Alderman Cady, Mayor Pro Tempor, stated that Improved Construction Methods of Jacksonville, AR is a sole source provider for the replacement tank for the vacuum tank on the Hurco valve machine. The letter will be attached to these minutes. Alderman Brooks made the motion to accept the recommendation of Ray Humphrey, Utility Director, and accept Improved Construction Methods as a sole source provider. Motion was seconded by Alderman Huling. Motion was put to vote and passed unanimously.

PLANNING AGENDA

Item #1 Application by Bankplus for subdivision approval to revise Freeport Industrial Park Subdivision Unit 1 on the south side of Stateline Road, west of Tulane. Mrs. Whitney Choat-Cook stated that the Bank has taken these lots back and they would like to merge the existing lots so they can combine all the lots. This was approved unanimously by the Planning Commission. Alderman Payne made the motion to approve Item#1 as presented to this board. Motion was seconded by Alderman Hale. Motion was put to vote and passed unanimously.

Item #2 Application to rezone property located on the west side of Garden Road between Long Street and Church Road requesting to be rezoned agricultural from R-20. Mrs. Whitney Choat-Cook stated that this was approved unanimously by the Planning Commission. Alderman Jobes made the motion to approve Item #2 as presented to this Board. Motion was seconded by Alderman Brooks. Motion was put to vote and passed unanimously.

MAYOR'S REPORT

Sheila Heath, City Clerk, asked to introduce a new employee. Chad Hendrix will be working in the City Clerk's Office. He thanked the Board of Alderman as they welcomed him.

COMMITTEE REPORTS:

Alderman Jobes reported that due to a recent motor vehicle accident involving a City employee in a City owned vehicle, we have received an offer from Travelers to settle the claim as a total loss. It would appear to be in the City's best interest to accept this and settle the matter. Pursuant to Mississippi Law regarding such property, Alderman Jobes makes a motion that the City declares the vehicle as surplus property and releases it to the Insurance Company. The vehicle is a 2005 Ford F-250, VN: 1FTNX20515EB03270. Motion was seconded by Alderman Brooks. Motion was put to vote and passed unanimously.

CITY ATTORNEY'S LEGAL UPDATE

Mark Sorrell, City Attorney, reported on a claim submitted by Mr. Tina Williams of 7435 Charleston Run Cove in Southaven. She is seeking reimbursement for property damage to her vehicle. After receiving the claim he spoke with Mr. Ray Tarrance, Public Works Director, who stated that he was unaware of the claim. He stated that the only place he saw on the street was washed out on the side of the road. He stated that no one informed him or his department of the condition of this area on Stateline Road. Based on the report Mr. Sorrell recommends that the claim be denied. Alderman

Payne made the motion to take the recommendation of Mr. Mark Sorrell, City Attorney. Motion was seconded by Alderman Huling. Motion was put to vote and passed unanimously.

OLD BUSINESS:

RESOLUTION CONCERNING MAYOR'S TRAVEL AND REIMBURSEMENT

WHEREAS, on November 16th, 1999 the Southaven Board of Alderman adopted a resolution, entitled "Resolution Concerning Duties of the Mayor," which set forth certain "duties" for the Office of the Mayor of Southaven; and

WHEREAS, the duties of the Mayor specified by the November 16, 1999 Resolution included: general control of the streets, avenues, and sidewalks being in proper repair, constant promotion of the City of Southaven, and being on call 24 hours a day, 7 days a week to respond disasters, police, fire, EMS, and other public safety calls; and

WHEREAS, the November 16th, 1999 Resolution allowed for expenditures of funds for promotion of tourism under HB 1618 of the 1993 Mississippi Regular Session; and

WHEREAS, the Resolution dated November 16th, 1999 was used by the Mayor as a basis for reimbursement of any and all travel and expenses conducted and incurred by him as part of his duties set forth in the November 16th, 1999 Resolution;; and

WHEREAS, the Resolution dated November 16th, 1999 shall be rescinded and new policies consistent with Mississippi law and regulations have been implemented to oversee funds expended for the purposes of travel and tourism under the authority granted of HB 1618 of the 1993 Mississippi Regular Session.

THEREFORE, be it resolved by the Mayor Pro Tempore and Board of Alderman that the Resolution dated November 16th, 1999 entitled "Resolution Concerning Duties of the Mayor" is hereby revoked and repealed and all future expenditures for the purposes of travel and tourism shall comply with the recently adopted policies passed by the Mayor and Board of Alderman of Southaven.

Upon motion made from Alderman Hale and seconded by Alderman Brooks, the aforesaid Resolution was voted upon with the following results, to-wit:

The said Resolution having received the affirmative vote of a majority of the members present, the Mayor Pro Tempore declared the motion carried and the Resolution adopted this the 3rd day of January, 2012.

Next, Alderman Hale asked to make a statement. He reported on the investigation with the Secretary of State's Office. He stated that on Wednesday, December 21, 2011, he, Alderman Guy and Alderman Brooks drove to Jackson, MS to hand deliver thousands of dollars of receipts and documents to the Office of the State Auditor. He reported that they met with the State Auditor, Stacy Pickering and members of his staff. He stated that they, meaning this Board, did not accept the vast majority of the receipts submitted by Mayor Davis as valid. They made their judgment known to Auditor Pickering. While a handful of these receipts were submitted by Mayor Davis as deemed valid, the majority of them were personal in nature and did not meet the requirement for reimbursement. The Board will continue to work closely with the investigators with the State Auditor's Office as we move forward with this matter.

Next, Alderman Jobes reported that the Meeting of December 20, 2011 the Planning Item for Clearview Baptist Church sign was tabled, requesting that they come before this Board to ask for a hardship for the new sign located on the Church's property. Alderman Jobes made the motion to remove this from the table and bring it back up. Motion was seconded by Alderman Payne. This issue is now open for discussion. Mrs. Choat-Cook stated that there were a few issues for this variance. She stated that they did have a hardship in some cases. She stated that they do have a temporary structure next to them that could block the sign. They are requesting to put the sign within the 10' ROW. They do have a 25' State ROW. Ron Smith, City Engineer, did go look at this request and stated that it would be a visibility issue. Next, Mr. Cory Nepshield, Pastor of Clearview Baptist Church, spoke to the Board. He stated that he disagrees with the visible issue. He stated that people are having a hard time finding their property because they set so far off the road. He then stated that they would keep the old sign as well. Mrs. Choat-Cook reported that that would be out of ordinance. Alderman Brooks stated that he also did not like the two signs there. Alderman Huling made the motion to table this for the Planning Department to investigate it further. Motion was seconded by Alderman Jobes. Motion was put to vote and passed unanimously. This item is now tabled until the next meeting.

Next, Alderman Brooks made the motion to uphold the termination discussed in Executive Session last meeting for the Parks and Fire Department. Motion was seconded by Alderman Payne. Motion was put to vote and passed unanimously.

PROGRESS REPORTS:

Alderman Jobes requested a report on the Northwest Drive project. Ron Smith, City Engineer, reported that the drainage part of the project is now completed. He stated that at this point they are putting down curbs and driveways. He reported that they are about ready to put the landscape islands in. Alderman Jobes asked if we were in budget with this project. Mr. Smith stated that we are in budget.

CLAIMS DOCKET:

A motion was made by Alderman Jobes to approve the Claims Docket of January 3, 2011, including demand checks and payroll in the amount of \$458,705.53. Motion was seconded by Alderman Hale. Alderman Cady opened the floor for discussion. There was no discussion, the motion was put to vote and passed unanimously.

Alderman Guy chaired the meeting as Mayor Pro Tempore. Mayor Davis was absent. Also present was Sheila Heath, City Clerk, Chris Wilson, City Administrator, Mark Sorrell, City Attorney and Whitney Choat-Cook, City Planning Director. Approximately one hundred (100) other people were present.

Alderman Guy, Mayor Pro Tempor stated that the motion dies with a 5-1 vote.

RESOLUTION ADOPTING REQUEST FOR RESIGNATION OF MAYOR CHARLES G. DAVIS

RESOLUTION OF THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF SOUTHAVEN, MISSISSIPPI CALLING FOR THE IMMEDIATE RESIGNATION OF CHARLES G. DAVIS FROM THE OFFICE OF MAYOR OF THE CITY OF SOUTHAVEN, MISSISSIPPI

WHEREAS, on or about November 2, 2011, Mississippi State Auditor Stacey Pickering did submit a formal demand for payment in the amount of \$170,782.28 in funds whereby Auditor Pickering stated "clothing purchases, counseling and personal meals and entertainment are in no way authorized expenses for the City and should not be paid for on the taxpayers' dime";

WHEREAS, Auditor Pickering further stated that such purchases and expenses served as a "betrayal of the public's trust";

WHEREAS, as of Tuesday, January 3, 2012, the full balance of such funds has not been submitted by Mayor Davis to the Office of State Auditor;

WHEREAS, the Mississippi Department of Transportation (MDOT) has informed the City of Southaven that funds appropriated to the City for various public work projects have been indefinitely suspended due to the nature of the ongoing investigations relative to Mayor Davis;

WHEREAS, on Tuesday, December 20, 2011, Mayor Davis informed all the members of the Southaven Board of Aldermen that he had in fact deliberately misled and lied to the Board for his own reasons.

NOW, THEREFORE, BE IT HEREBY RESOLVED that we the members of the Board of Aldermen of the City of Southaven, Mississippi, after having reviewed and contemplated the above mentioned factors and after having reviewed thousands of dollars in receipts and spending records produced by

Mayor Davis, do hereby call for the immediate resignation from the Office of Mayor of the City of Southaven, Mississippi, by Charles G. Davis and that a special election to fill the vacancy in the Office of the Mayor of the City of Southaven, Mississippi, take place as in accordance with Mississippi state law. Following the reading of said Resolution, it was introduced by Alderman Hale and seconded by Alderman Brooks.

Alderman Guy, Mayor Pro Tempore, opened the floor for discussion. Alderman Cady asked has this been reviewed by the Attorney. Alderman Hale stated that it has been reviewed by the Attorney. Next, she asked if the receipts were available to the public. Alderman Guy stated that they are if the Public Records Request procedure is done. Alderman Huling stated that a motion of resignation is not an official Board action. The Board has no authority to take this action and if this Board continues this, it shows that this Board is taking this action that's not a legal action. He further states that the only way a Mayor can be removed from Office is if he is charged and convicted in a court of law. These are quotes from the State of Mississippi Attorney Generals options. He feels like this should have been handled in Committee meeting when Mayor returns. He stated that all of the comments he has made in no way, shows that he approves of what Mayor Davis has done, the charges that have accrued or actions that have yet to be determined. Alderman Huling states that the only way the Mayor can leave office is for him to turn in his resignation. And, if he changes his mind, there is nothing this Board can do. He asked this Board to withdraw this resolution and demonstrate true leadership. Alderman Guy stated that we have been quiet too long about what's gone on and the action we are taking. He hopes that the action they are taking will show the citizens of Southaven that we are willing to take action. Alderman Hale stated that we are aware of the fact that we can't make the Mayor resign, but

Staff Comments:

The applicant is requesting a variance to allow six (6) foot monument sign to be erected directly behind the MDOT right-of-way on Goodman Road. Sign regulations for monument signs states that a sign may be place no less than ten (10) feet behind the current right of way for the road abutting the site. MDOT regulates right of way for Goodman Road, which is shown as ninety (90) feet in this particular area of Goodman. The applicant is requesting to erect the sign at $(90 \frac{1}{2})$ feet which encroaches into the required ten (10) feet by $(9 \frac{1}{2})$ feet. The applicant believes there to be a hardship on the visibility due to the farmers produce market to the west of the site. The church has an existing sign off of the access to the east. They want to improve the signage and relocate it into the actual drive.

Staff Recommendation:

The ordinance requiring channel letters signage was put in place in 2006 to aid the City in creating a more uniform sign package for the City as a whole. According to the requirements of a variance application, the applicant must prove a hardship on the site for approval of such variance in one or more of the following situations:

- ➤ Is there a special condition and/or circumstance that exist which are peculiar to the land, structure or building involved and which are not applicable to other lands, structures or buildings in the same district? Yes. The MDOT right of way varies greatly along Goodman Road, at this particular area, the right of way requires ninety (90) feet from the center line south, which is a large amount of frontage for sites.
- ➤ Is there a literal interpretation of the provisions of this title that would deprive the applicant of rights commonly enjoyed by other properties in the same district under the terms of this title? NO
- ➤ Is there a special condition and/or circumstance that do not result from the actions of the applicant? Staff would state the same MDOT reasoning as in the first situation described.
- Would granting the variance requested confer special privileges that are denied by this title to other lands, structures, or buildings in the same district? Possibly. Since the right of way does vary in other areas, a variance for this particular site may create a special privilege that has not been or may not be granted to others with the same hardship.

Although staff does see some hardship for the church site, we have visited the site and do not believe the additional 9½ feet would create a visibility issue for the church. Also, the City Engineer visited the site to ensure site visibility where the proposed site would be located and determined that their existing sign is basically the same distance from the road as a sign "in compliance" would be. Staff further does not feel comfortable recommending a variance for the main reason given by the church that "Worleys Market" blocks their view from the west. Although it has been there a few years, and stays on site 6-8 months out of the year, it is still considered a temporary establishment with temporary signage and a temporary building. If a permanent commercial site were to be constructed here, staff would require the same setbacks for the building and the sign to ensure no visibility blocking of the surrounding properties. With that being said, staff recommends denial of the variance and request that the church place the sign the addition 9½ feet further back onto the property to comply with our sign regulations.
