## **PERMIT**Indoor Display of Pyrotechnics

The applicable NFPA standards and the following requirements shall be met in order to obtain a valid permit. Permits must be obtained a minimum of 10 working days prior to the event.

1) Provide the following information for the individual, group, or organization sponsoring the

indoor pyrotechnics display before a proximate audience.

2) Provide the following information for the supplier of the fireworks to the operator, if different than that of the operator.

3) Provide an insurance certificate or bond attesting to coverage or responsibility.	
4) Date and Time of pyrotechnics display	
5) Exact location planned for fireworks display.	
6) Provide confirmation of training and experience of the operator in charge of the display and the number of assistants that are to be present. Names and ages of assistants and their general duties are to be provided.	d
7) List the quantity and types of fireworks to be discharged.	

8) Identify the manner and place of storage of such fireworks to be discharged. Comply with

the requirements of N.F.P.A 1126.

- 9) Provide a diagram of the location of which the indoor pyrotechnics display is to be held designating the point at which the materials are to be discharged, the location of all stages, adjacent seating, and areas where persons will be near the effects as they are discharged. The person in charge of the facility shall receive a copy of the sketch so that proper clearances may be maintained from combustible materials. Any materials located in the vicinity of the display must meet the required flame spread requirements. Personnel should be aware of sequence of events so that persons are not allowed to enter the display zone. The diagram shall be as specified in N.F.P.A. 1126.
- 10) An adequate number of spotters shall be provided to maintain security of pyrotechnics and use fire extinguishers as necessary. These persons shall be trained for above activities. There shall be a means of communication provided so that the display can be stopped if necessary.
- 11) Provide proof of permission obtained from the property owner allowing the pyrotechnics display to take place on the property.
- 12) A representative of the Southaven Fire Department will be present when deemed necessary by the Fire Marshal's office. Fees for pyrotechnic permit shall be the responsibility of the party responsible for the display and provided prior to issuance of the permit.

## **Applicant Certification**

I certify that I am familiar with and will comply with the requirements of the Southaven Fire Code in addition to N.F.P.A 1126(Indoor Display of Pyrotechnics Display before a Proximate Audience, N.F.P.A. 1124 (Manufacture, Transportation, And Storage of Fireworks) and N.F.P.A. 106 (Flame Effects before an Audience). Furthermore, I will comply with all regulations and requirements of adopted and regulated by the federal government and local jurisdictions for the safe transportation, storage and use of pyrotechnics before a proximate audience.
